Angela McIver, CEO of Fair Housing Rights Center of Southeast Pennsylvania moderated an engaging discussion on the timely topic of gentrification. Realtor Arlene Waynes, Philadelphia Councilman Curtis Jones, and PHRC Executive Director Chad Dion Lassiter shared their perspectives on how to address investing in communities without displacing community members.

Abraham Pardo Reyes, Director of Housing at the Urban League of Philadelphia, shared about their initiative to combat racial inequalities in homeownership and increase homeownership opportunities for households of color. PHRC Director of Fair Housing, Adrian Garcia gave a crash course in structural inequality in housing, providing a brief history of restrictive zoning and redlining and how they impact housing issues today. Interim Chief Counsel Martin Cunningham shared about the urgency of housing cases, and the power of the Pennsylvania Human Relations Act (PHRA) to prevent immediate and irreparable harm in cases that have been filed. Rachel Wentworth from the Housing Equality Center shared about her agency's work in addressing disparate impact housing discrimination, highlighting some recent settlements that addressed policies of housing providers that restricted housing opportunities based on national origin, race, familial status, and source of income. ## Fred Banuelos, Federal Home Loan Bank of Pittsburgh

Fred took conference attendees on a deeply personal journey through how housing impacted his family's history and his work at the Federal Home Loan Bank of Pittsburgh. He shared about how domestic violence, immigration, housing conditions, financing, and education impact housing opportunities and health, He also highlighted his professional journey from home construction and real estate to work at a public housing authority and affordable housing development, to the opportunities to work towards housing equity through Special Purpose Credit Programs.

Tara Ulrich and Maria Williams, from the PA Coaltion Against Domestic Violence (PCADV) shared about the importance of housing for survivors of domestic violence. They shared about the need for increased housing protections at the state level, the importance of safety planning, and the importance of ensuring domestic violence survivors can access housing options.

Ray Michalowski, Senior Prosecutor at the Pennsylvania Department of State shared key information about appraiser/appraisal bias, highlighting how historic decisions, systemic issues, and actions by appraisers can impact fair appraisers.

#### SUPPORTING EFFORTS THAT SUPPORT NEIGHBORS WHILE IMPROVING NEIGHBORHOODS

Chad Dion Lassiter, MSW

- Develop a fair housing guide on gentrification
- Partner with local agencies that support neighborhood residents and elevate those perspectives to a state-wide level
- Take enforcement actions when members of protected classes are being displaced due to development
- Actively engage in local issues to prevent situations that displace local residents



#### FOSTERING HOUSING JUSTICE FOR DOMESTIC VIOLENCE SURVIVORS

- Offer ongoing training to PHRC staff to ensure skilled investigations into fair housing cases with a disparate impact on survivors of domestic violence
- Foster advocacy efforts to advance state protections for survivors of domestic violence



#### PREVENTING APPRAISAL BIAS

- Partner with PA Appraisal Board staff to investigate cases of appraisal bias.
- Provide fair housing training & resources to Appraisal Board staff
