PCN will produce and air Fair Housing programming developed by the PHRC titled: *Pennsylvania Human Relations Commission Speaks: Fair Housing in the 21st Century*. PCN will provide introduction with music, lower third identification, and full screen graphics for ten (10) episodes plus a 30-second promotional spot that will run four (4) times per day the week prior to run schedule during an approximately three month time frame.

Because PCN has the capability to provide both content, promotion and distribution of this event, and they have worked in this capacity with other Commonwealth PA agencies in the past, they are the best vendor to procure this service from.
