A) Reason(s) for Sole Source Procurement:

Only a single contractor is capable of providing the service.

The PHRC intends to retain the services of John Quiñones to present a speech and for him to engage in discussion to address historic discrimination and racism based on National origin in America titled "A 20/20 Vision for America: Building Bridges, Not Walls" for its groundbreaking Social Justice Lecture Series.

C) Describe the unique features/compatibility of the supply, service or construction item that precludes competitive procurement.

Because Mr. Quiñones has a singular background, style and opinion in an area of law enforced by the PHRC, there are no other persons that can fulfill this service for the PHRC. Mr. Quiñones, a former child of a poor family of migrant workers, overcame socio and racial barriers to become the American Broadcasting Company's first Latino correspondent and a seven-time Emmy Award winner. Mr. Quiñones offers a powerful story emphasizing the role education played in his own success to propel him beyond societal racial discrimination and stereotypes. Additionally, PHRC seeks to celebrate Hispanic Heritage Month and unite the Hispanic Activism Community in the Commonwealth and believe that such a speaker, who has united various communities throughout the country provides such an opportunity. American Program Bureau, Inc. is the lone agent for John Quiñones.
